



Attendance Verification (cont.)

General Information

Total CECH will be calculated from each physician's attendance verification records. These hours will be submitted to CE Broker by FPMA at the conclusion of the conference, once all hours have been verified, and for FPMA Members, all 2024 membership dues have been paid in full. Florida Podiatric Physicians can view these hours via their CE Broker account at www.cebroker.com. Podiatric Physicians from other states will be sent certificates showing total CECH earned by attending SAM 2024.

SAM 2024 attendees will be awarded up to 25.25 Continuing Education Contact Hours. Continuing Education Contact Hours (CECH) are calculated hour-per-hour based on courses attended (time taken for breaks and meals are NOT counted); e.g., a 30 minute Science lecture will earn 0.5 Science credit hours, a one-hour Science lecture will earn 1.0 Science credit hours, a 1.5 hour Practice Management lecture will earn 1.5 PM credit hours, etc.

All licensees who seek to renew the active status of their licensure must demonstrate that they have completed, during the previous two years, at least forty (40) hours of continuing education, including the following categories:

- At least one (1) of the forty (40) hours must concern the topic of Risk Management.
- At least one (1) of the forty (40) hours must be on the topic of Laws and Rules.
- At least two (2) of the forty (40) hours must be on the subject of prevention of Medical Errors.
- At least two (2) of the forty (40) hours must be on Prescribing Controlled Substances.
- While not required, licensees may complete up to three (3) hours of continuing education per biennium in the area of Practice Management.
- The remainder of the hours can be made up of Scientific hours.

Please be advised that if you are within your **first biennium of license renewal** and need to satisfy the requirement for attending a Florida Board of Podiatric Medicine meeting at which disciplinary hearings are conducted, we wish to inform you that the Florida Board of Podiatric Medicine will hold a meeting (disciplinary hearings currently indicated) on Friday, January 26, 2024 on-site at the SAM 2024 host hotel Hyatt Regency Orlando in the **Barrel Spring meeting room** beginning at **9:00 a.m.** Please be advised that a parking fee of \$27.00 for self-parking or \$40.00 for valet parking will apply for non-registered hotel guests care of the Hyatt Regency Orlando.

First Biennium Renewal: As provided in subsection 64B18-17.005, F.A.C., Podiatric Physicians initially licensed in the biennium or within 24 months of initial licensure are required to obtain five (5) hours of continuing education in the subject area of risk management which may be obtained by attending one full day of a meeting of the Board of Podiatric Medicine at which disciplinary hearings are conducted. The practitioner is then exempt from any other continuing education requirements for his or her first renewal except for a 1-hour course on human trafficking and the hours mandated for prevention of medical errors and HIV/AIDS.






